

Long Term Outcomes of Computer-Navigated Lateral Opening Wedge Distal Femoral Osteotomy for Lateral Compartment Knee Arthrosis*

Abstract

Objective The primary aim of the present study was to evaluate the long-term outcomes including survivorship of computer navigated distal femoral lateral opening wedge osteotomy (DFLOWO). The secondary aim was to identify the potential factors that may influence its survivorship.

Methods A retrospective analysis of prospectively collected data for patients with lateral compartment arthritis who underwent navigated DFLOWO from December 2006 to November 2012 was performed. The International Knee Documentation Committee (IKDC) and Knee Injury and Osteoarthritis Outcome Score (KOOS) scores were analyzed for outcome measures. Conversion to arthroplasty during the follow-up was the end point.

Results A total of 19 DFLOWOs were performed in 17 patients with a mean age of 46.6 ± 6.5 years formed the study cohort. The coronal alignment was corrected from a mean of 7.1° ($2\text{--}11^\circ$) valgus to a mean of 2.1° ($0.5\text{--}3^\circ$) varus. The IKDC scores improved from mean of 39 preoperatively to 53 at the mean long-term follow-up of 9.1 years. The mean KOOS scores at the long-term follow-up were pain 71, symptoms 56, activities of daily living 82, sports and recreation 59, quality of life 43. Survivorship of the DFLOWO was 78.9% at a follow-up of 9.1 years. Presence of \geq grade 2 according to the International Cartilage

Repair Society (ICRS) cartilage degeneration in the medial compartment of the knee and $>7^\circ$ preoperative valgus deformity were strongly correlated with conversion to total knee arthroplasty (TKA) at the long-term follow-up ($r = 0.66$).

Conclusions Computer navigated DFLOWO has satisfactory clinical outcomes and 79% survivorship in long-term follow-up. Presence of more than ICRS \geq grade 2 degenerative changes in the medial compartment of knee with $>7^\circ$ preoperative valgus deformity negatively affects the survivorship of DFLOWO in the long-term follow-up.

Resumo

Objetivo O objetivo principal do presente estudo foi avaliar os resultados a longo prazo, incluindo a sobrevivência em Osteotomia Varizante Femoral Distal com Cunha de Abertura Lateral (OVFD-CAL) utilizando navegação computadorizada. O objetivo principal do presente estudo foi avaliar os resultados a longo prazo, incluindo a sobrevivência.

Métodos Foi realizada uma análise retrospectiva dos dados coletados prospectivamente de pacientes com artrite do compartimento lateral submetidos a OVFD-CAL por navegação de dezembro de 2006 a novembro de 2012. As pontuações International Knee Documentation Committee (IKDC, na sigla em inglês) e Knee Injury and Osteoarthritis Outcome Score (KOOS, na sigla em inglês) foram analisadas para medição de resultados. Conversão para artroplastia durante o acompanhamento foi o ponto final.

Resultados Um total de 19 pacientes submetidos a OVFD-CAL com média de idade de $46,6 \pm 6,5$ anos formaram a coorte do estudo. O alinhamento coronal foi corrigido a partir de uma média de $7,1^\circ$ ($2-11^\circ$) de valgo para uma média de $2,1^\circ$ ($0,5-3^\circ$) de varo. As pontuações do IKDC melhoraram de uma média pré-operatória de 39 para 53 no acompanhamento de médio de longo prazo de 9,1 anos. Os escores do KOOS no acompanhamento a longo prazo foram: dor 71, sintomas 56, atividades da vida diária 82, esportes e recreação 59, qualidade de vida 43. A sobrevivência do OVFD-CAL foi de 78,9% em um acompanhamento de 9,1 anos. Presença de degeneração da cartilagem segundo a Sociedade Internacional de Reparação de Cartilagem (International Cartilage Repair Society [ICRS, na sigla em inglês]) \geq grau 2 no compartimento medial do joelho e deformidade pré-operatória em valgo $>7^\circ$ fortemente correlacionado com a conversão para artroplastia total do joelho (ATJ) no acompanhamento a longo prazo ($r = 0,66$).

Conclusões A OVFD-CAL por navegação computadorizada apresentou resultados clínicos satisfatórios e sobrevivida de 79% no acompanhamento a longo prazo. Presença de alterações degenerativas maiores que ICRS \geq grau 2 no compartimento medial do joelho com $>7^\circ$ de deformidade pré-operatória em valgo afeta negativamente a sobrevivência da OVFD-CAL no acompanhamento de longo prazo.

Introduction

Osteotomy of the distal femur (DFO) to address symptomatic degeneration in the knee is a well-established procedure¹ with good results reported in the literature.² Broadly, the osteotomy is based on either an opening³⁻⁶ or a closing⁷⁻¹² wedge alignment technique. Several patient-related parameters including age, gender, body mass index (BMI) and surgical factors such as osteotomy site, gap, and fixation technique, amongst others, have been demonstrated to influence the outcome of DFO. Preopera-

tive planning based on imaging is vital to assess the type and extent of deformity correction to be undertaken to achieve optimal alignment.^{13,14} Computer-assisted surgery (CAS) has been extensively used as a dynamic intraoperative alignment aid in knee arthroplasty, providing good outcomes.¹⁵ Several investigators in the current literature have utilized computer navigation in proximal tibial osteotomy and reported improved accuracy in realizing the planned alignment.¹⁶⁻¹⁸ However, there is paucity of studies reporting the long-term outcomes of distal femur lateral opening-wedge (DFLOWO) using computer

navigation. Through our study, we aim to report on the long-term outcomes and survivorship of computer navigated DFLOWO.

Methods

Ethics committee approval was obtained for the present study. Due consent was taken for the use of data from all the patients of the present study. A retrospective analysis of prospectively collected data for patients with lateral compartment arthritis who underwent navigated lateral opening wedge distal femoral osteotomy from December 2006 to November 2012 was performed. Consecutive patients of lateral compartment knee arthrosis aged < 55 years old who failed to respond to conservative management were included in the study. Patients who had end stage arthritis with fixed flexion deformity of > 15°, < 90° of knee flexion or who did not consent with the procedure were excluded.

The included patients were operated by one of the three senior surgeons attached to our research institute. The included patients were followed-up with clinical and radiological evaluation at regular intervals (6 weeks / 6 months / 1 year / 5 years). The final follow-up for the included patients was done using an email questionnaire of the patient-reported outcomes measures. Conversion to either unicompartmental knee arthroplasty (UKA) or total knee arthroplasty (TKA) during the follow-up was the end point. Additionally, this information was verified from the Australian Orthopaedic Association National Joint Replacement Registry (AOANJRR) database.¹⁹

Surgical Technique

The surgery was performed in the supine position. The preparation was made, as well as free sterile draping of the lower limb. Femoral and tibial trackers were inserted to register the landmarks for measuring the limb alignment using navigation. The three surgeons used two different navigation systems, including ORTHOSoft (Zimmer, Warsaw, IN, USA) and OrthoMap Precision Knee Navigation (Stryker, Kalamazoo, MI, USA). First, the center of the femoral head was registered. Subsequently, diagnostic arthroscopy was performed, and any arthroscopically treatable intra-articular causes of knee pain were addressed. The International Cartilage Repair Society (ICRS) grade of the knee articular cartilage was documented for the medial compartment, the lateral compartment, the patella and the trochlea. Registration of remaining landmarks was then completed including the center of the distal femur and the proximal tibia as well as the femoral condyle and tibial plateau and the malleoli.

A lateral skin incision of between 12 and 15 cm was made from the level of the lateral knee joint line proximally. The fascia lata was incised immediately posterior to the iliotibial band and the vastus lateralis was exposed and elevated anteriorly off the lateral intermuscular septum. Subperiosteal posterior femoral soft tissue dissection was performed to separate the posterior neurovascular structures from the posterior femoral surface. Protective soft tissue retractors were used to protect the neurovascular structures and the

anterior extensor mechanism. Utilizing fluoroscopic guidance, a guidewire was passed from the middle of the lateral femoral surface just proximal to the superior pole of the patella and slightly oblique to the axial plane, aiming slightly distally toward the adductor tubercle. Utilizing fluoroscopy and a sagittal saw, the osteotomy was commenced through the metaphyseal bone from lateral to medial immediately proximal to the guidewire. While the saw was utilized for osteotomy of the lateral and anterior femur, a sharp osteotome was used to perform osteotomy of the posterior cortex. The medial hinge of the intact bone was preserved by carefully advancing the saw and the osteotome up to but not beyond the line corresponding to the lateral face of the medial femoral condyle. After osteotomy, the alignment was corrected to a neutral mechanical axis under the guidance of navigation, using a laminar spreader to create a controlled gap at the osteotomy site with care to not alter the femur in the sagittal plane. Once adequate correction was achieved, the wedge-shaped bone void was filled with allograft and the osteotomy was stabilized with a plate fixation.

Postoperatively, the limb was held in full extension in a limited range of motion brace, which was opened to allow a range of 0 to 30° on the first postoperative day. Part weight bearing mobilization was allowed with support – initially one quarter of the body weight as tolerated by the patient and increasing by one quarter of the body weight every 2 weeks. At 2 weeks, the brace was opened to allow a range of 0 to 90° and gradual flexion was allowed with supervision by a physiotherapist until the 6-week mark, when the brace was discontinued. Use of crutches is continued as needed and after 6 weeks physiotherapy regime was upgraded from range of motion to strengthening exercise program. This was continued till the patient was able to full weight bear and walk with support.

Outcome Measures and Statistics

International Knee Documentation Committee (IKDC)²⁰ and Knee Injury and Osteoarthritis Outcome Score (KOOS)²¹ were prospectively collected. The IKDC score was obtained preoperatively and at 1 year and then at the long-term follow-up (> 6 years), and the KOOS scores were recorded at the long-term follow-up (> 6 years). The collected data was recorded on a Microsoft Excel (Microsoft Corporation, Redmond, WA, USA) spreadsheet and analyzed using IBM SPSS Statistics for Windows Version 24 (IBM Corp., Armonk, NY, USA). Descriptive statistics including mean, standard deviation (SD) and range were quantified for all recorded data. The Student *t*-test and analysis of variance (ANOVA) were used to compare the means of 2 or > 2 independent groups, respectively. Linear and multiple regression analyses were used to identify the factors correlating with conversion to TKA.

Results




Fig. 1 Comparative long-term survivorship of DFOs. **Legend:** The image is a comparative bar chart of the long-term survivorship of DFOs performed for lateral compartment knee arthrosis. [DFO: Distal femoral osteotomy; DFLOWO: distal femoral lateral opening wedge osteotomy; DFMCWO: distal femoral medial closing wedge osteotomy].




Fig. 2 Comparative bar chart of IKDC score. **Legend:** The image is a comparative bar chart which depicts the change of IKDC scores from the preoperative to the long-term follow-up [DFO: Distal femoral osteotomy; DFLOWO: distal femoral lateral opening wedge osteotomy; DFMCWO: distal femoral medial closing wedge osteotomy].




Fig. 3 KOOS score of DFLOWOs at long-term follow-up. **Legend:** The image is a comparative line diagram depicting long-term follow-up KOOS scores of DFLOWO [DFLOWO: distal femoral lateral opening wedge osteotomy].

A total of 19 DFLOWOs were performed in 17 patients including 11 males and 6 females. The mean age was 46.6 ± 6.5 (33–53) years. A total of 15 of the 19 DFLOWOs (78.9%) had a

previous history of partial lateral meniscectomy. The coronal alignment was corrected from a mean of 7.1° (2–11°) valgus to a mean 2.1° (0.5° - 3°) varus. The sagittal alignment was corrected from a mean of 7.5° (0–11°) of flexion contracture to a mean of 1° (0–3°) of flexion contracture. A total of 4 out of 19 DFLOWOs were converted to TKA. Thus, the survivorship of navigated DFLOWO in our study cohort was 78.9% at a mean follow-up of 9.1 years (►Fig. 1). The IKDC scores improved from a mean of 39 in the preoperative period to 58 at the 1-year follow-up and deteriorated to 53 at the mean long-term follow-up of 9.1 years (►Fig. 2). The KOOS scores at the long-term follow-up were: pain 71, symptoms 56, activities of daily living 82, sports and recreation 59, quality of life 43 (►Fig. 3). The knee range of motion for the cohort ranged from a mean of 3° of flexion contracture to 124° of maximum flexion. The degree of preoperative valgus deformity negatively correlated with survivorship (Pearson’s correlation coefficient [PCC]: - 0.49; *p* = 0.03). Also, presence of ≥ grade 2 ICRC cartilage damage in the medial compartment of the knee with higher preoperative valgus deformity (> 7°) was strongly correlated with conversion to TKA at the long-term follow-up [*r* = 0.66; *p* = 0.002] (►Table 1).

Apart from conversion to TKA, 12 additional surgical interventions were performed in the study cohort during the follow-up period. These included: i) hardware removal (9), ii) bone graft and stabilization (2) for nonunion and iii) revision fixation (1) for peri-implant fracture secondary to a fall at 6 months after the primary surgery, which progressed to satisfactory union following intervention. One patient suffered from deep venous thrombosis after the procedure and was adequately treated without any long-term consequences.

Discussion

There has been a resurgence of interest in DFO to manage lateral compartment knee arthritis especially in the young and active population group. This interest has stemmed from the improvisation in surgical techniques and the availability of better fixation implants. A major technical advancement has been the use of computer navigation to achieve accurate correction. Although DFLOWO has recently gained popularity over the conventional distal femoral medial closing wedge osteotomy (DFMCWO),^{1,2} there is paucity of studies in the current literature reporting the long-term outcomes and survivorship following DFLOWO.²

Our study is the first to report the long-term survivorship of 78.9% at 9.1 years of follow-up for computer-navigated DFLOWO. The only other study which reports on the clinical outcomes of computer navigated DFO is by Saragaglia et al.²² It included patients who have undergone either a DFLOWO or DFMCWO and reported the clinical outcomes at a mean medium-term follow-up of 50.9 months. At the last follow-up, none of the included patients were converted to TKA. A recently published study by Shivji et al.²³ described the clinical outcomes of large cohort patients from a single center who underwent either DFMCWO or DFLOWO. The patients included in their cohort underwent DFO after modern digital planning with use of precise surgical instruments to achieve accurate correction and stabilization with precontoured locking plate fixation. They reported an overall survival of 89% at 10 years. The long-term survival of osteotomy in our study is inferior to the one described by Shivji et al.²³ Including patients of only DFLOWO and not a

mixed cohort of DFLOWO and DLMCWO could explain this difference. Also, when we compare the published survival rates of DFOs with this study, it is evident that the long-term survival of computer-navigated DFLOWO is better than the survival of non-navigated DFLOWO, but inferior to survivorship of non-navigated DFMCWO (► Fig. 1).

Use of knee arthroscopy at the time of performing navigated DFO facilitated knowledge of accurate status of articular cartilage damage. Patients who had \geq grade 2 ICRS

cartilage damage in the medial compartment of the knee and had $> 7^\circ$ of preoperative valgus were more likely to be converted to TKA ($r = 0.66$). This important information can aid in preoperative decision-making and postoperative patient counselling. Assessment of articular cartilage status based on radiographs can underestimate the cartilage damage. Thus, efforts should be made to gain information about the status of the knee cartilage from old patient records, if patients had undergone previous knee arthroscopy. Young

patients with lateral compartment knee arthrosis with ≥ grade 2 ICRS cartilage damage in the medial compartment of knee and > 7° of valgus limb alignment should be duly informed about the high chances of DFLOWO failing and of the need of a second surgery for conversion to TKA in the long-term follow-up.

The long-term KOOS scores of patients who underwent DFLOWO in our study were similar to those reported by Ekeland et al.¹ in their series of patients who underwent non-navigated DFLOWO (►Fig. 3). When compared with the published long-term IKDC scores of patients who underwent non-navigated DFMCWO, the results were mixed (►Fig. 2). Long-term IKDC scores of navigated DFLOWO patients in our series were either similar or marginally inferior to those of non-navigated DFMCWO; but no direct comparison and conclusions could be drawn as these studies were heterogeneous.

Our study had certain limitations. Although our study was done using the data of patients belonging to one institute, the included patients belonged to three different surgeons who made use of two different navigation systems. Although all the surgeons were fellowship trained knee surgeons and made use of similar surgical techniques, there were differences in the type of fixation and bone graft used. Also, the total number of DFLOWOs included in the study was small when compared with some other published series.

Conclusions

Computer-navigated DFLOWO has satisfactory clinical outcomes and 79% survivorship in long-term follow-up. Presence of ICRS ≥ grade 2 degenerative changes in the medial compartment of the knee with > 7° preoperative valgus deformity negatively affects the survivorship of DFLOWO in the long-term follow-up.
